THIS VENDOR AGREEMENT (this "Agreement"), made and entered into as of the \_\_\_\_\_ day of \_\_\_\_\_, is by and between O2M Productions LLC, ("O2M"), located at PO Box 234, Menomonee Falls, Wisconsin, and \_\_\_\_\_ ("Vendor"), located at \_\_\_\_\_, \_\_\_\_\_, Wisconsin.

Vendor hereby agrees to the above-selected package. Vendor must pay O2M a deposit in the amount equaling 50% of the total amount due. This deposit is nonrefundable and due when you sign this Agreement. **Your remaining balance must be paid to O2M prior to July 1st, 2011.**

It is understood and acknowledged by the Vendor that O2M retains the sole and final discretion and authority regarding (1) the details of the Wedding Show & Tell (the "Show"), (2) acceptance of any and all vendor(s) and (3) cancellation. Should O2M, or the property owner, decide to cancel the Show, or your appearance at the Show, for any reason, including, but not limited to, inclement weather, safety and/or health concerns, facility problems, etc., you will not be entitled to any costs, expenses or damages resulting from the cancellation – this includes, but is not limited to, your nonrefundable deposit, lost profits, consequential or incidental expenses, etc.

Should you, the Vendor, have to cancel, at any time after signing this Agreement, you must notify O2M in writing. If O2M receives your cancellation notice after July 1st, 2011, you will remain responsible for the full amount of this Agreement and O2M is not obligated to refund any of your money. If O2M receives your cancellation notice on or before July 1st, 2011, you will not be responsible for paying O2M the balance you owe on the full amount of this Agreement; however, O2M will not be responsible for refunding your deposit.

Vendor shall be solely responsible for any loss, damage, disappearance or other casualty to any of its (or its employees', agents', or subcontractors') personal property, including vehicles, equipment and supplies (collectively "Vendor Personal Property") and shall indemnify and hold O2M harmless from the same. Vendor shall be solely responsible to protect its personal property.

Vendor shall cause its employees, agents, and subcontractors to conduct themselves in an appropriate, non-hostile and workmanlike manner when implementing the terms of this Agreement and when interacting with any person or persons while on the Property or as part of any gathering sponsored by O2M. O2M may remove and exclude any person or persons if, in its sole and absolute discretion, it determines that this provision has been violated. Vendor further covenants and agrees that it will at all times, protect, indemnify, save and keep O2M and Waukesha County, and their respective agents, employees, volunteers, members, and invitees forever harmless from any damages, expenses, costs, including reasonable attorney fees, and any other liability in connection with any accident, action, claim, or other occurrence arising out of or related to any and all intentional, reckless, or negligent acts or omissions of Vendor, and its employees, agents and subcontractors.
